The 2021 budget increase overall spending \$72,530, or 7.5%. Amount to be raised by taxes increases \$74,786. The District is budgeting increased Debt Service due to a new capital lease being entered into in 2021.

Administrative salaries will increase \$13,400, due to Commissioner salaries increase \$2,500, as well as an increase in office salaries of \$9,500. Office expense will increase by \$2,000, and election costs will increase \$500 due to increased administrative duties related to elections and notices. Debt Service increase \$44,138 due to a new capital lease in 2021.

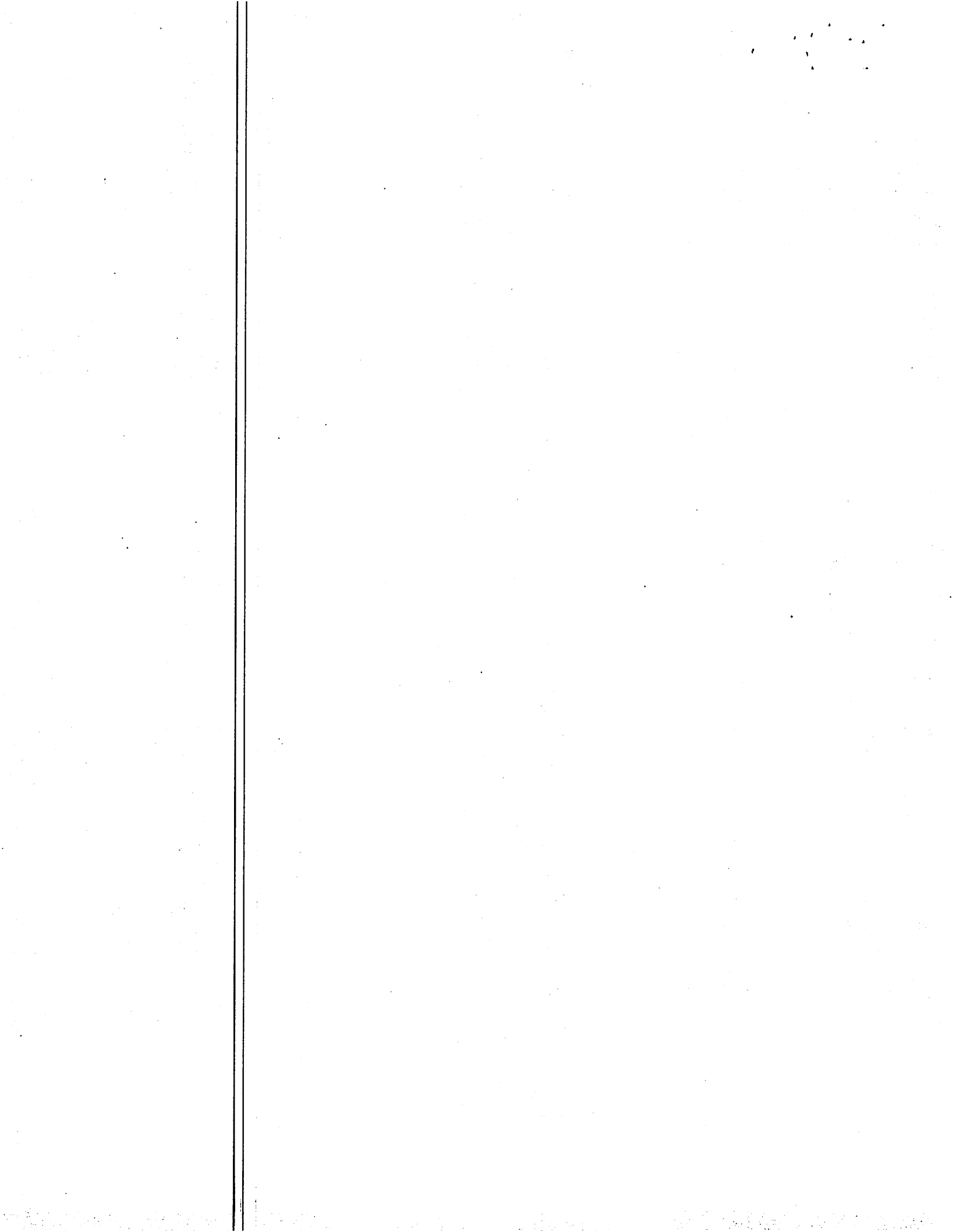

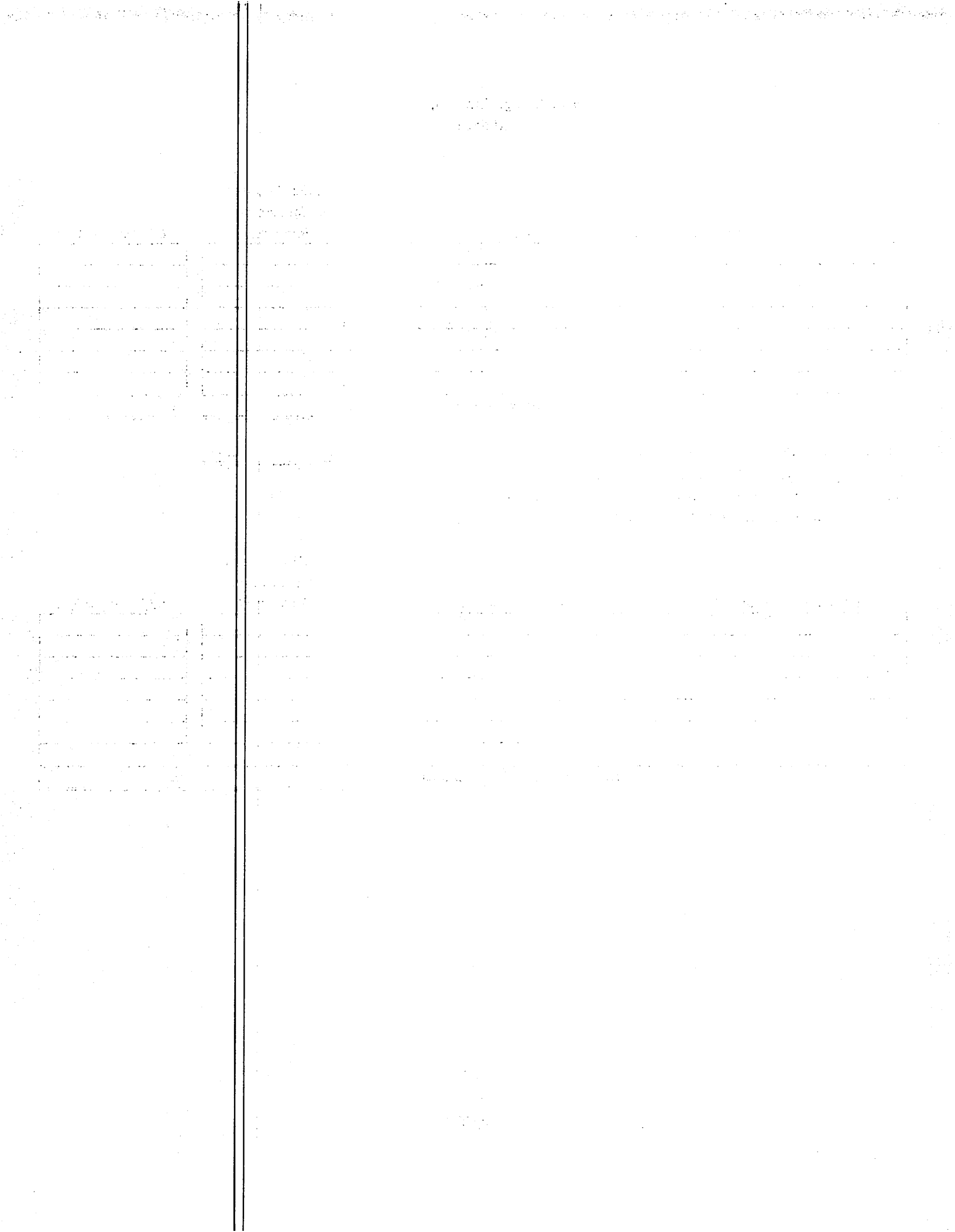
