WHEREAS, the Annual Budget for Woodbridge Township FD No. 8 (the 'Fire District') for the fiscal year beginning January 1, 2024 and ending December 31, 2024 has been presented before the Board of Commissioners of the Fire District at its open public meeting of November 28, 2023; and

WHEREAS, the budget as introduced is in compliance with the Property Tax Levy Cap Law (N.J.S.A. 40A:4-45.44 et seq.); and

WHEREAS, the Annual Budget as introduced reflects Total Revenues of \$1,154,597.94 which includes an amount to be raised by taxation of \$1,104,814.94 and Total Appropriations of \$1,154,597.00; and

WHEREAS, the amount to be raised by taxation to support the district budget shall be the amount to be certified to the assessor of the municipality to be assessed against the taxable property in the district, pursuant to N.J.S.A. 40A:14-79. Such amount shall be equal to the amount of the total appropriations set forth in the budget minus the total amount surplus and miscellaneous revenues set forth in the budget; and

WHEREAS, in calculating the amount to be raised by taxation, the Fire District has taken into account the assessed valuation of taxable property in the Fire District;

NOW, THEREFORE BE IT RESOLVED, by the Board of Commissioners of the Fire District, at an open public meeting held on November 28, 2023 that the Annual Budget, including all related schedules, of the Fire District for the fiscal year beginning January 1, 2024 and ending December 31, 2024 is hereby approved; and

BE IT FURTHER RESOLVED, that the anticipated revenues as reflected in the Annual Budget are of sufficient amount to meet all proposed expenditures/expenses and all covenants, terms and provisions as stipulated in the Fire District's outstanding debt obligations, capital lease arrangements, service contracts, and other pledged agreements; and

The 2024 budget as proposed increase the amount raised by taxation from \$1,032,871 to 1,140,814, an increase of \$71,943. Overall appropriations decrease \$103,771. primarily as a result of a decrease in capital appropriations of \$75,000 and decreased debt service.

3. Explain any variances over +/-10% for each line item. Attach in FAST any supporting documentation that will help to explain the reason for the increase/decrease in the budgeted line item.

Accountant fees increase \$5,000 due to increased work on District elections as well as increased web-site maintenance. Engineer costs increase due to increased work on district information systems. Insurance is being budgeted to increase \$12,000 in order to be in line with actual results. Joint Board expense increases due to Districts cost of township wide- smoke trailer. Training Expense increases 20% due to more training offered to volunteers. Cost of Operations & Maintenance- Personnel decrease 100% due to the elimination of part time position. Maintenance & repair - Apparatus increase \$5,000 due to estimated costs of repairs on its current fleet. Salary & wages for Appropriations Offset With Revenue will increase \$6,000 along with Fringe Benefits associated with this increasing \$661 due to increased hours worked by the Inspector. Capital appropriations decrease \$75,000 because the District will not be buying any new capital assets in 2024. Debt Service expense will decrease due to the elimination of one of the Districts capital leases. Interest income is budgeted to increase \$8,500 due to more available funds on hand being invested in higher yielding accounts. Annual Registration Fees increase \$7,771.50 due to increased enforcement and growth in the District.

If Unrestricted Fund Balance is reduced by more than 10%, explain the projected impact on the following year's budget.

Amount to be raised by Taxes increases \$71,943, while the District will be utilizing \$7,471.50 in unrestricted Fund Balance. This will have no impact on the 2025 budget.
