

The 2025 budget proposes an overall 2.3% increase in appropriations from 2024. The amount raised by Taxation increases 2.3%, or \$26,789.50. This increase is within the statutory CAP limit.

Audit fees increase \$2,000 due to increased work needed on PERS and OPEB liability deferrals and accruals. Snow removal costs increase \$2,000 based upon prior years experience. Payroll process fees increase due to initial year of outside payroll preparation. Cost based upon quotes from service providers. Cost of physicals increase due to expected increase in volunteers. Cost of repairs to communication equipment increases due to required upkeep of existing equipment. Interest payments decrease due to lower principal balance due on outstanding capital leases.
