Bureau issued two permits to Express Container Service at

155 Smith Street for welding and combustible liquid storage.

2. Bureau investigated complaints on April 3<sup>rd</sup> for 155 Smith Street for water flow alarm. New water flow switch was installed.

3. Bureau investigated complaints on April 6<sup>th</sup> for WaWa on Route 9 for a fire alarm issue. Alarm company was on scene making the necessary repairs to put the system back in service.

- 4. Bureau investigated complaints on April 8<sup>th</sup> for 155 Smith Street for multiple water flow alarms. This condition was caused by numerous water pressure issues due to the large brush fire in Raritan Center. The sprinkler company came in and adjusted the setting and all was good.
- 5. Bureau investigated complaints on April 18<sup>th</sup> for Hampton Inn on Route 9. There was a couple using incense in the room which activated the fire alarm inside the room and were advised not to use the incense anymore.
- 6. Bureau investigated complaints on April 19<sup>th</sup> for Pathmark on New Brunswick Avenue where the main entrance was obstructed by displays. Imminent hazard was ordered and issued and these displays were immediately removed.
- 7. Bureau investigated a car fire on April 12<sup>th</sup> in the parking lot of a Church on Clyde Avenue. Fire was not suspicious in nature.
- 8. Bureau was notified by the county regarding two children.
- 9. Bureau was notified by the Woodbridge Police regarding a juvenile caught setting fire and will enter the fire watch program.

## FIRE CHIEF'S REPORT:

- 1. Follow up from the last meeting regarding policy to go out. There is going to be no policy. Will just go off as past practice, what is written in the bylaws. Already stated where everything is covered.
- 2. There's a little delay on the percentages. Will get the percentages out as soon as everything is squared away and the computer up and running in full strength.
