FIRE OFFICIALS REPORT MAY 2017

The Bureau received a set of plans for the Lionelli property (The old Shines Meat Market) on the corner of Florida Grove Road and Luther Ave for a 20-unit apartment building to be built on the site.

An extensive report was written requiring a Class One stand pipe system, NFPA type 13 sprinkler system, depressed curbing in the parking areas and driveway entrance and exit, fire zones and lanes, a remote FDC located on Luther Ave and a double barrel fire hydrant on the corner of South Charles Street and Luther Ave connected to the 20-inch water main.

The hearing was held on May 18th at Town Hall before the Zoning Board and the public came out to testify against the proposed project.

The Zoning Board did not approve the application and voted the project down.
I will keep the Board advised if I receive any further correspondence for this site.

Avenel Fire Prevention Bureau provided Mutual Aid investigated an open burning compliant on May 19th on Oregon Ave after the fire department responded to a call.

I will be following up on the incident once I receive the report from Avenel.
